UNIFORM POLICY

School has policies and procedures to ensure that it meets its legislative obligations in relation to student welfare – Safe and Supportive Environments B8

Rationale

This policy outlines the expectations of the Al Hikma College is regards to its uniform.

Expectations

- All students are required to wear the College uniform whilst at, and travelling to and from the school
- Uniforms must be kept neat and presentable, hygienically clean and in good condition at all times
- The uniform is to be properly presented and worn correctly at all times
- Shirts must always be kept tucked in
- Jumpers are not to be worn around the waist
- Singlets, T-shirts, etc., should not be seen below sleeves of shirts or at neck level
- Singlets under shirt must be white with no print
- Girls skirt hemlines must be below the knees
- The uniform is not permitted to be worn with 'non-uniform' clothing
- Shoes must be black or brown leather school shoes. Runners (this includes black runners) or boots are not regulation school shoes
- Jewellery other than a watch is not permitted. In terms of earrings
- Make-up and nail polish are not permitted
- Extreme hairstyles are not permitted, e.g. undercuts, steps and lines. Boys' hair should be one length and kept clean and tidy. Hair should be kept in its natural colour, tied back and be free of all hair products and accessories. The ultimate judgement on the appropriate hairstyle **must rest** with the Principal.
- No smartwatches permissible on school grounds
- In the event a student shows signs of head lice, they will be sent home for a total of three days. It is expected parents will take the necessary treatment precautions to kill the lice.

Breaches of uniform policy

- A written note signed by a parent is required on the day that the student is out of uniform
- Students who breach the school uniform policy will have a letter sent home explaining the breach
- Students who continue to breach the school uniform policy will be issued with a warning letter
